

# ECCL Report: November 9, 2018

**Executive Summary:** 177th meeting of the Estero Council of Community Leaders



Lee Health Coconut Point: Lee Health Coconut Point opens on Monday, December 3. The public is invited to attend a Community Open House on Saturday, November 17 that will begin at 7:30am with a 5K walk/run. The festivities and tours will begin at 9:00am. LHCP is still recruiting volunteers for anyone interested in volunteering.

Estero on the River Property Purchase: The Village Council will have workshops on November 28 and December 5 to discuss outstanding land

use and real estate issues and to review the financing alternatives for the purchase of the "Estero on the River" property. The anticipated closing on the property is January 14, 2019.

**Estero Educational Outreach Council (EOC):** The EOC has begun organizing the classroom assignments for the Junior Achievement Spring semester classes and the spots are filling up fast. The Naples Daily News, NBC2, and ABC7 are all doing stories about the outstanding Estero JA program. Any Estero residents that would like to be mentors for the Fall program at FGCU's Institute for Entrepreneurs should reach out soon.

**Proposed Development of Weeks Fish Camp by London Bay Homes:** London Bay Homes is proposing a 300 unit continuing care retirement community and reactivation of a small marina on the former Weeks Fish Camp property. The recently filed application will be reviewed by the Bonita Springs Planning & Zoning Board and approved by the Bonita City Council.

**Village Report:** The Village of Estero is now a "Purple Heart Village." The Village Council has also approved the development of a Parks and Recreation Master Plan for Estero. The ordinance to place skimmers as gas stations in Estero was also approved. The Village has authorized the purchase of a 62-acre parcel of the "Estero on the River" property. All Estero and surrounding area residents are invited to Estero's "Salute to Veterans" event on Saturday, November 17.

**County Traffic Study:** ECCL Transportation Director Bob King requested information on Tasks 6, 7, & 8 of the AIM/Corkscrew Road Report through the Freedom of Information Act. Bob King and Pete Cangialosi presented information on the cost of the needed roadway improvements, the required environmental improvements, and the proportionate share analysis.

**Estero Heart Fair:** The inaugural Estero Heart Fair is scheduled for Saturday, March 2, 2019. Community members are encouraged to reach out with input and help plan this event. The fair is looking for volunteers from each community to attend planning meetings.

**Finance Committee:** The ECCL is creating a Finance Committee of experienced financial professionals. If anyone is interested in joining, please contact Finance Director Bob Lienesch.

**Environmental Committee:** The date has not been set for the Planning & Zoning Board Meeting for Argo Development's plans for the development of Corkscrew Crossing on Corkscrew Road. The Burnett Oil Company that was given permission to explore for oil in the Big Cypress Preserve has not been cleaning up properly. Please consider sending an email expressing your concerns about its activities.

#### Staffing Update

- EFR has hired two new employees.
   They are replacements for a promotion and a retiree.
- Over the next 3-4 years, EFR will be hiring 9-12 people for the new station on east Corkscrew Rd.

#### • Growth & Land Acquisition

Fire Chief Vanderbrook met with
 Village Manager Steve Sarkozy to discuss village growth and started negotiating with 4-5 people to obtain land for EFR to build new facilities during the next 5, 10, and 15 years.

#### • Storm Update & Prep

- There is still an engine crew in the Florida Panhandle to help with Hurricane Michael wreckage and search and rescue.
- EFR fire stations have good funding to prepare for storms and have survived hurricanes before. Estero Fire Rescue is building the new Station 45 to withstand 175 mile per hour winds.




- come and prepare a story about JA career success and air a TV special.

- Financial Report Summary
  - Expenses for the month of October came totaled approximately \$1,700. This included internet communications, media, PR, and printing.
  - Excess of expenses over income for 2018 is about \$9,500.
  - The ECCL's cash balance as of September 30, 2018 is \$8,745.
- Dues for 2019
  - The ECCL has agreed that it needs a modest increase in dues (\$50-100)
  - Amount will be based on community size:
    - 0 350 residential units = \$400
    - 351 700 = \$450

701 - 1,100 = \$650
 1,101 - 1,500 = \$700
 >1,500 = \$800
