The ECCL Annual Report

The Estero Council of Community Leaders (ECCL) is indebted to you for your continued investment in our community improvement efforts to ensure that the quality of life that everyone enjoys in greater Estero is maintained and enhanced. It has been a highly active year for us, and we prepared this report to keep you updated.

A brief history of the ECCL, established in 2004, will help to explain the positive impact of its persistent and committed unpaid volunteers that created our sought-after destination in Southwest Florida. You will see the significance, influence, and contribution of the ECCL on many issues that may be unknown or taken for granted.

While there have been many notable achievements, two stand out. At the comprehensive planning and zoning level, the ECCL made a difference in countering the development community's pressure and influence. Without ECCL's activities, the area would have been unchecked and adversely impacted Estero's architectural style.

The Village of Estero would not exist today if it weren't for the ECCL's efforts over the last 20 years. The upfront and behind-the-scenes work conducted by the ECCL leading to the incorporation of the Village of Estero in 2014 was vital in preventing the increasing effort by Bonita Springs to annex various sections of Estero to boost their tax revenues. There is a clear benefit to the "checks and balances" that the ECCL provides to rigorously evaluate the decisions affecting our area and influencing our lifestyle.

Past Lee County Commissioner Frank Mann said, "If the ECCL had not been there, we might have seen a large part of Lee County looking like wall-to-wall concrete, which I fear and oppose, as do you guys. Had the ECCL not been there, I just don't know what would have happened!"





Other selected activities and achievements in collaboration with other community organizations and advocates include:

- Prevented Estero from being annexed into Bonita Springs
- Stopped a major intersection at I-75 at Coconut Road
- Participated in the development of Coconut
 Point Mall
- Significant impact on the development and design of Walmart Estero
- Limiting mining expansion in the DR/GR (Density Reduction Groundwater Resource)
- Reducing the noise from flights in and out of RSW Airport
- Planning and advocating for the development of Lee Health at Coconut
 Point

- Convincing the Lee County BOCC to use the conservation 2020 funds to purchase Edison
 Farms in 2017
- Transportation and related achievements include:
- Estero Parkway and Three Oaks right turn lane
- o Turnaround at the Three Oaks Post Office
- East Corkscrew Road widening
- Turn lanes into Estero High School
- Traffic light at US 41 and Pelican Colony
- Adopt a Highway on a four-mile section of Tamiami Trail (removed 8 tons of trash)
- An all-volunteer Junior Achievement "2-5-8-Graduate" program adopted by the ECCL and implemented in four Estero schools.

Why we exist focuses on informing greater Estero citizens of critical issues needing attention and encouraging engagement to impact our quality of life favorably.

The ECCL is now a 501(c)3 Non-Profit Organization

Previously, the ECCL operated as a 501(c)4 organization with the expanded ability for political lobbying, and contributions were not tax-deductible. Recently the ECCL was classified a 501 (c)3 organization by the IRS because the organization provides information to Greater Estero residents about issues that could positively or negatively impact the quality of life in Greater Estero. With the 501c3 classification, the ECCL can solicit tax-deductible contributions to support our efforts directly. The 501(c)3 designation will help the ECCL continue its focus on monitoring and education to engage the community to improve the environment, safety, transportation, health, and education.

We have established a volunteer Finance Advisory Committee within the ECCL. The committee will provide the Chief Financial Officer, Executive Management Team (EMT), and the Board of Directors an outside independent resource that is recommended for all Not-for-Profit 501(c)3 Organizations.

Cooperation with other Organizations

The ECCL has agreed on a partnership arrangement with the Calusa Waterkeeper Organization and the Sanibel-Captiva Conservation Foundation to increase our impact on specific issues such as water quality and environmental issues. We are also in a relationship with FGCU's Water School.









Key issues that have been Communicated and Addressed since January 2022

Hurricane Ian and the storm surge from Estero Bay severely impacted the residents along West Broadway. We joined forces with the Estero Forever Foundation, Estero Chamber of Commerce, and the Village of Estero and were instrumental in raising more than \$100,000 for the victims. Our volunteers also organized a 2-day barbeque event and provided a forum for residents to receive information about storm relief.

The ECCL awarded **\$2,500** grants to Operation Barbeque Rescue, Riverwoods Plantation Foundation, and Estero Baptist Church for their support of this effort. The ECCL supported the local education community with a \$5,000 Diamond sponsorship for Bonita Springs High School and Estero High School, Jaws vs. Claws IV fundraiser.

During the year, the **ECCL's Monthly Meetings** have hosted many significant speakers that have addressed various essential topics. Some of those that have spoken either at the Zoom meetings or, more recently, our in-person meetings have included:

The ECCL **donated \$3,000** to the Historical Society to help pay for the work needed to ensure the historic buildings are in good order for the benefit of the community. The ECCL also sent out a request to residents to help donate funds for this successful purpose.

The article by **Spotlight Magazine** to be published in mid-February highlights our organization's new name and focus and will provide considerable insight and understanding of **Engage Estero's** purpose and mission.

The ECCL's Book "Forging a Better Path" (sent as a complimentary copy to Members), which outlined the work of the ECCL over the last 20 years, was serialized in the Seabreeze and other publications.


The ECCL's **Adopt a Highway program** has continued to be extraordinarily successful. Since October 2020, the total litter collected along Hwy 41 between the Vines entrance (Breckenridge Road) to Coconut Road has been an astounding 9,380 pounds (just under 8 tons). Now, every section of the county roads in Estero has an Adopt a Road program through Lee County's Adopt a Road program. Volunteers have adopted other county road sections in Estero from Country Creek, Estero Rotary Club, River of Life Church, Suffolk Construction, Pro-line, and several FGCU organizations. In addition, with the support of the Estero Village Manager Steve Sarkozy and the Keep Lee County Beautiful program, an Adopt a Road program was initiated this season for:

- Estero Parkway (led by volunteers in the Cascades)
- Via Coconut Point (led by volunteers in Genova and including participants from Rapallo, Mirasol, Colonial Oaks, Shadow Wood, Wildcat Run, and Lighthouse Bay)
- Williams Road (with volunteers from Genova and Pelican Sound).



Some Future Developments



The ECCL is initiating a series of **Public Forum** (Town Hall Style) meetings. The first, scheduled for January 25, 2023, and held at FGCU's Water School (details are on the www.esterotoday.com website, will focus on Water Quality and Environmental Issues impacting Greater Estero.

We are scheduling other forums covering Community Health and Local Development in the coming months. These will supplement the regular ECCL Monthly Meetings.



The Education Council is recruiting volunteers to continue the widely praised JA program for Estero's students towards the end of 2022. In addition, Mike Wasson, the Education Council's Co-chair, examines how the ECCL could implement an Ambassador Program for local schools.



The **Safety Council** monitors road and other Village capital improvement projects and, where necessary, proposes practical adjustments to benefit residents.



The Transition from the ECCL to Engage Estero


The ECCL completed a review of the organization's purpose, mission, and vision to clarify the work and focus of the organization. We consulted with Eric Dent and Craig Randel, currently FGCU professors. We shared a draft of our effort to date and the results of the recent resident survey. At subsequent meetings with the members of the EMT, the consultants challenged aspects of our rebranding effort. Selected comments and recommendations are included in our recommendations.

During September 2022, we surveyed residents' views of the ECCL, Estero, and the surrounding communities that would help direct our future activities and actions and identify their key priorities. There were more than 800 responses. In addition, more than 600 respondents wrote about personal perceptions, beliefs, criticisms, and suggestions.

Key Findings

- 12% claimed to know a lot about the ECCL.
- 36% said a moderate amount.
- 33% said they had little knowledge.
- 19% said they knew nothing.

We asked, "Is there a need for a community-based, 501c3 nonprofit, nonpartisan, nonpolitical, and volunteer community organization?



The reasons the respondents considered the ECCL necessary included:

- We need nonpartisan and nonpolitical groups in our divided society.
- To be a voice for responsible growth and environmental issues.
- Keep development to a minimum to maintain our quality of life.
- To help shape Estero's future.



Regarding our actions, while all items listed were considered necessary, the following were the top 5 cited.

- 1. To help protect our environment and preserve our clean water and wetlands.
- 2. To inform about Village, County, Regional, and State issues and ways to respond to issues threatening the quality of life in our communities.
- 3. To function as a watchdog organization to monitor the implementation of Village of Estero initiatives and plans.
- 4. To proactively respond to perceived immediate threats to our quality of life.
- 5. To help improve our safety by supporting the funding and planning for safe and adequate roadways, walking/biking/and multi-use paths serving our communities.


